

artist agreement for Sunday Orphans' Salon

to be held 7-9pm on Sunday, \_\_\_\_\_, at shadowlands Bookstore & Cafe, 5254 College Avenue, Oakland, California, 94618.

The salon format is as follows: 7:00p arrival with informal meet + greet of attendees; 7:30p host's introduction; 7:35p informal guided presentation with samples of work, including intermittent questions by host in order to prompt artist to give deeper insight into their creative process, tools used, and personal history. 8p questions are open to participants; 8:25p wrap-up; 8:30-9p informal chatting and sale of any artist wares (items and/or gift certificates, etc). The purpose of the session is to provide a platform for showcasing the components of creative generation. Presenter allows the audience insight into personal experiences (to the extent desired) that led to the full blooming of their craft, as well as the thought process and practical tools applied in its refinement and editing to 'perfection'. The hope is that the act of articulating this to an audience using chosen snippets, as though explaining to a class of bright, attentive schoolchildren, will enhance understanding and respect for the effort and expense of pursuing a craft at such a high level.

100% of cover charges will be due to the presenter at the close of session. Cover will be set by venue in consultation with the presenter. Presenter is encouraged to enlist a friend to help with the post-presentation sale of merchandise or special offers to attendees. Please note that venue shall not participate in the sale of such items, and all proceeds remain with presenter. In the event of sickness, accident, natural catastrophe, or other unforeseeable events that may prevent presenter from attending the session or venue from hosting, venue and presenter would work together to reschedule the event for a future date.

Venue shall publicize sessions through its website, in-store, and submit event listings in local newspapers, for which presenter's professional biosketch and images may be used to aid in promoting the session. Presenter is asked to assist in securing attendees to the extent feasible and practical, by utilizing digital outlets, social media, print flyers, and/or other advertisement to the presenter's own network. Presenter recognizes that success of the event relies on both parties investing a little time in getting the word out. Presenter understands and agrees that audience members may record portions of the session and post to social media; venue may also utilize excerpts and/or photos for promotional purposes.

Presenter agrees that the venue shall not be held liable for personal items or equipment in the event of theft or damage. In case of any property damage, personal injury or harm to an audience member due to intentional or grossly negligent actions, presenter understands that venue or the building owner shall not be responsible. The presenter is an independent contractor and nothing in this agreement shall be interpreted or misconstrued as creating any relationship of employment between the parties.
